



Name of Work :- Repair and renovation works for Oxygen manifold room in the existing ward Master's office and the adjacent rooms in the compound of Dr. J.R. Dhar SD Hospital at Bongaon during 2018-19.

This estimate has been framed to meet up the probable expenditure for the above noted work. As per joint visit 20.06.2018 by WBMSCL team with P.W.D. the spot was identified for Oxygen manifold room. For this purpose, the ward master's office and the adjacent rooms have been proposed. The ward master's office to be shifted another adjacent room. Therefore some repair and renovation works to be done for proposed room.

So the essential items have been provided in the estimate as dismantling the toilet block, and some part of shed (M.S), B.W. wood work. Plastering, painting etc. Thus the estimated cost stands Rs. 1, 29,800.00 including 12% G.S.T., 1% Labour welfare Cess and 3% Contingency.
