

1. In addition, they will get HRA@12% subject to maximum Rs. 12,000/- p.m. No Medical Allowance will be admissible.
2. Annual enhancement of contractual pay will be @ 1%, 2% and 3% depending upon the performance as recorded in the earlier observation of Finance Department vide U.O. No- Group-P1/2020-2021/0367 dated 12.02.2021 read with Group-P2/2019-2020/0364 dated 07.08.2019 may be made on 1st January of every calendar year.



3. Other terms and conditions as per the previous order of WBMSCL vide no. WBMSC/HR/2524/19/2457 dated 21-Oct-2019 issued in terms of the earlier notification of Health & Family Welfare Department vide no. HF/O/GA/3046/MS/WBMSCL-01/2017 dated 26.09.2019 read with Finance Department U.O. no. Group-P2/2019-2020/0364 dated 07.08.2019 shall remain same.


