Sir,

With reference to the above, it is stated that the work order was issued to you for repairing and servicing of the existing Fire Fighting, Fire Detection & Alarm System and renewal of the Fire Life Safety Certificate at Baruipur Super Specialty Hospital, with a stipulated completion period of 60 days.

However, despite repeated instructions and sufficient opportunities, you have failed to commence/complete the assigned work within the stipulated time. The Fire Fighting, Fire Detection & Alarm System still remains in an incomplete/non-functional condition, due to which the required Fire Safety NOC/renewal of Fire Life Safety Certificate cannot be obtained in the present condition. This is a serious concern considering the life-safety requirements of a functioning Super Specialty Hospital.

Despite the final direction issued vide letter dated 23/07/2026 to complete the work within the stipulated additional period, no satisfactory compliance has been made.

In view of the above persistent failure and breach of contractual obligations, the aforesaid Work Order is hereby terminated with immediate effect, as per the terms and conditions of the Contract/NIT.

Necessary action regarding forfeiture of Security Deposit/Performance Security and other penal measures, including debarment/blacklisting shall be taken separately as per the applicable provisions.
